MINUTES

15-minute session for members of the public to speak

2 residents attended the meeting. Both from Oakridge Park.

The Chairman invited the member of public from Oakridge Park to speak. The resident explained to parish council how they felt the developers were in breach of planning.

The Chairman responded by explaining the developers are not in breach of planning. He continued by adding that the work had been started but had not been completed to date. He further suggested that the resident get back in contact with the developers and the solicitors in order to help resolve the matter.

The second member of public didn't bring anything to the meeting they were there just to observe.

Parking Management Scheme Presentation

The Chairman explained the parish council had invited a representative of Milton Keynes Council, Paul Harrison, to make a presentation with regards to a parking management scheme – item 126/18. Mr Harrison handed out paper copies of proposals 1-13 and explained to the parish council he and the Chairman had looked at areas highlighted as ones of concern. Mr Harrison had obtained some costings but were still waiting for information from Bancroft, Blue Bridge, Bancroft Park, along with Oakridge Park and some areas of Bradville.

MKC will arrange everything, including the consultation, public notices and SPC website.

They try to run in conjunction with parish councils – approximately 4-6 weeks. This also includes Traffic Order to be paid for by MKC.
