

**--- PROPOSED ORDER ---**

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES  
(VARIOUS ROADS WITHIN BANCROFT, BANCROFT PARK, BLUE  
BRIDGE, BRADVILLE, OAKRIDGE PARK AND STANTONBURY)  
(PROHIBITION OF WAITING) ORDER 2020**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2) and 4 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**PART 1**

**IMPLEMENTATION, CITATION AND DEFINITIONS**

1. This Order shall come into operation on the        day of        2020 and may be cited as "The Council of the Borough of Milton Keynes (Various Roads within Bancroft, Bancroft Park, Blue Bridge, Bradville, Oakridge Park and Stantonbury) (Prohibition of Waiting) Order 2020".
  
2. In this Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:-
  - "access way" means a length of road sufficient to enable a vehicle to have access to and egress from land or premises in or adjacent to the said road;
  - "Civil Enforcement Officer" ("CEO") has the same meaning as in Section 76 of the Traffic Management Act of 2004;
  - "Council" means The Council of the Borough of Milton Keynes;
  - "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;
  - "disabled persons' badge" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
  - "disabled persons' vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
  - "goods" includes postal packets of any description, cash or other valuable securities;
  - "goods vehicle" means a motor vehicle which is constructed or adapted for the carriage of goods of any description and which does not exceed 3.5 tonnes gross laden weight;
  - "passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver, and not drawing a trailer;

"postal packets" has the same meaning as in Section 125 of the Postal Services Act 2000;

"restricted road" means a road which is subject to parking and waiting restrictions;

"road" means a highway and any other road to which the public has access;

"statutory undertaker" has the same meaning as in Section 329 of the Highways Act 1980;

"telecommunications apparatus" has the same meaning as in the Telecommunications Act 1984;

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the Act of 1984;

"Verge" means a strip of land usually grassed alongside a carriageway between the carriageway and the pavement.

3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
4. The plans annexed to this Order identify the roads and areas subject to this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules which shall prevail.

## **PART 2**

### **PROHIBITION OF WAITING**

5. No person shall except with the permission or under the direction of a police officer in uniform, a traffic warden or a Civil Enforcement Officer (CEO) cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 1 hereto.
6. No person shall except with the permission or under the direction of a police officer in uniform, a traffic warden or a Civil Enforcement Officer (CEO) cause or permit any vehicle to wait at any time on any of the lengths of verges specified in Schedule 2 hereto.
7. Nothing in Articles 5 and 6 above shall render it a contravention of this Order to cause or permit any vehicle to wait in any of the lengths of road or verge specified in Schedules 1 and 2 for so long as may be necessary:-
  - (1) to enable goods to be loaded or unloaded from the vehicle;
  - (2) to enable a person to board or alight from the vehicle;
  - (3) If the vehicle is a goods vehicle and is delivering and/or collecting;

- (4) when the person in control of the vehicle is required by law to stop or is obliged to stop in order to avoid an accident or is prevented from proceeding by circumstances outside his control;
  - (5) for a vehicle to wait whilst any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait outside otherwise than in a length of road specified in Schedule 1 to this Order while such gate or other barrier is being opened or closed;
  - (6) to enable the vehicle, if it cannot reasonably be used for such purpose in any other road, to be used in connection with any of the following:-
    - a) building, industrial or demolition operations;
    - b) the removal of any obstruction to traffic;
    - c) the laying, erection or repair of any sewer, main, pipe or apparatus for the supply of gas, water, electricity or any telecommunication system defined by the Telecommunications Act 1984;
    - d) use in the service of any undertaker, the Environment Agency or any public authority in pursuance of statutory powers or duties;
    - e) any wedding or funeral;
    - f) use for police, military, fire brigade or ambulance purposes;
    - g) use for the purpose of delivering or collecting postal packets as defined by section 125 of the Postal Services Act 2000;
    - h) the vehicle being specially constructed or adapted for the delivery or collection of money or valuable securities to be used for those purposes in relation to premises in the vicinity;
    - i) to carry out the removal of furniture or household effects to or from a shop, office, depository or dwelling house in the vicinity.
8. In accordance with the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000, nothing in Article 5 shall render it a contravention of this Order to cause or permit a disabled person's vehicle which displays a disabled person's badge and parking disc in the relevant position in accordance with Articles 9 and 10 hereof to wait in any of the lengths of road specified in Schedule 1 hereto.
9. For the purposes of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position under the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 if:-

- (1) the badge is exhibited on the dashboard or fascia of the vehicle so that the front of the badge is clearly legible from the outside of the vehicle; or
  - (2) where the vehicle is not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle so that the front of the badge is clearly legible from the outside of the vehicle.
10. For the purposes of this Order a vehicle shall be regarded as displaying a parking disc in the relevant position under the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 if:-
- (1) the disc is exhibited on the dashboard or fascia of the vehicle so that when marked to show the quarter hour period during which a period of waiting began, that period is clearly legible from the outside of the vehicle; or
  - (2) where the vehicle does not have a dashboard or fascia, the disc is exhibited in a conspicuous position on the vehicle so that, when marked to show the quarter hour period during which a period of waiting began, that period is clearly legible from the outside of the vehicle.

### **PART 3**

#### **ENFORCEMENT OF RESTRICTIONS**

11. The Council shall, on or in the vicinity of a restricted road:-
- (1) Highlight each restricted area with notices, signs and road surface markings in accordance with the Traffic Signs Regulations and General Directions Act 2002;
  - (2) Maintain and from time to time alter the said notices, signs and road-surface markings;
  - (3) Carry out such other work as is reasonably required for the purpose of the satisfactory operation of a restricted road.
12. The Council shall appoint Civil Enforcement Officers whose duty it shall be to patrol and enforce the waiting and parking restrictions imposed by the Articles of this Order.

- NW3 From a point 38.5 metres south of a point opposite its junction with the centreline of Haltonchesters, for a distance of 33 metres in a southerly direction
  
- NW4 From a point 49.5 metres north of its junction with the centreline of Milecastle, for a distance of 33 metres in a north-westerly direction

**HADRIANS DRIVE AND CASTLESTEADS**

**SOUTH SIDE AND EAST SIDE**

- NW5 From a point on Castlesteads 25 metres south of its junction with Hadrians Drive, for a distance of 32 metres in a northerly then easterly direction onto Hadrians Drive

**SOUTH SIDE AND WEST SIDE**

- NW6 From a point on Castlesteads 41 metres south of its junction with Hadrians Drive, for a distance of 46 metres in a northerly then westerly direction onto Hadrians Drive

**HADRIANS DRIVE AND OCTAVIAN DRIVE**

**NORTH-WEST SIDE**

- NW7 From a point on Hadrians Drive 30 metres south-west of its junction with the centreline of Chesterholm, for a distance of 31 metres in a south-westerly, then north-westerly, then south-westerly direction

**SOUTH-EAST SIDE AND NORTH-EAST SIDE**

- NW8 From a point on Hadrians Drive 30 metres south-west of a point opposite its junction with the centreline of Chesterholm, for a distance of 25 metres in a south-westerly, then south-easterly direction

**HADRIANS DRIVE AND RUDCHESTERS**

**NORTH SIDE AND EAST SIDE**

- NW9 From a point on Rudchesters 12 metres north of its junction with Hadrians Drive, for a distance of 49 metres in a southerly then easterly direction onto Hadrians Drive

#### **NORTH SIDE AND WEST SIDE**

NW10 From a point on Rudchesters 12 metres north of its junction with Hardrians Drive, for a distance of 33.5 metres in a southerly then westerly direction onto Hadrians Drive

#### **MILECASTLE**

##### **WEST SIDE AND NORTH SIDE**

NW11 From a point in line with the shared boundary line of numbers 65 and 66, for a distance of 20 metres in a southerly then westerly direction

##### **EAST SIDE AND NORTH SIDE**

NW12 From a opposite point in line with the shared boundary line of numbers 65 and 66, for a distance of 38 metres in a southerly then easterly direction

##### **SOUTH SIDE**

NW13 From a point in line with the shared boundary line of numbers 50 and 51, for a distance of 18 metres in an easterly direction

NW14 From a point in line with the south-eastern boundary wall of number 30, for a distance of 11 metres in an easterly direction

##### **NORTH-EAST SIDE**

NW15 From a point in line with the shared boundary line of numbers 27 and 28, for a distance of 18 metres in an south-easterly direction

##### **SOUTH-WEST SIDE**

NW16 From a point in line with the shared boundary line of numbers 28 and 29, for a distance of 10 metres in an north-westerly direction

#### **OCTAVIAN DRIVE**

##### **NORTH-EAST SIDE**

NW17 From its junction with Monks Way (H3), for a distance of 49 metres in a north-westerly direction

#### **OCTAVIAN DRIVE AND KENCHESTER**

##### **SOUTH-WEST SIDE AND SOUTH-EAST SIDE**

NW18 From a point on Octavian Drive at its junction with Monks Way (H3), for a distance of 53 metres in a north-westerly then south-westerly direction onto Kenchester

##### **SOUTH-WEST SIDE AND NORTH-WEST SIDE**

NW19 From a point on Kenchester 10 metres south-west of its junction with Octavian Drive, for a distance of 20 metres in a north-easterly then north-westerly direction onto Octavian Drive

## **RICHBOROUGH**

### **NORTH SIDE AND WEST SIDE**

NW20 From a point 40 metres east of its junction with Hadrians Drive, for a distance of 15 metres in an easterly then northerly direction

### **SOUTH SIDE AND WEST SIDE**

NW21 From a point 40 metres east of its junction with Hadrians Drive, for a distance of 15 metres in an easterly then southerly direction

NW22 From a point 51 metres south-east of its junction with Millers Way (H2), for a distance of 25 metres in a south-easterly direction

NW24 From a point 124 metres south-east of its junction with Millers Way (H2), for a distance of 10 metres in a south-easterly direction

## **CONSTANTINE WAY AND LULLINGSTONE DRIVE**

### **WEST SIDE AND NORTH SIDE**

NW25 From a point on Constantine Way 51 metres south-east of its junction with Millers Way (H2), for a distance of 75 metres in a south-easterly then westerly then northerly direction onto Lullingstone Drive

NW26 From a point on Constantine Way 35 metres south-east of its junction with the centreline of Lullingstone Drive, for a distance of 69 metres in a northerly then westerly direction onto Lullingstone Drive
