This camera has been deployed due to ongoing environmental issues within the area.

Within the month of July, we identified three littering offences within this area. So far, one of these offences has been fully investigated by Milton Keynes Environmental Crime Unit and this driver has received a fixed penalty notice for the offence of littering. We received a request to review footage due to report of vandalism to a property nearby to where the camera is deployed. We reviewed a large amount of footage and provided information to the Police on this.

During the month of June, we identified two separate littering offences, we are now aware that two separate fixed penalty notices have been issued to the two drivers who littered.

In May, we identified four separate littering offences from vehicles. All of these individuals have now been issued with a fixed penalty notice.

This camera is in place due to reports of littering, regular gatherings, and drug activity.

During the month of July, we identified one individual litter a food bag out of their car and into the road before driving off, we have created and supplied an evidence pack for this to Milton Keynes Environmental Crime Unit. This is currently being investigated.

We regularly re-angled this camera to the opposite side of the area, due to reports of anti-social behaviour from vehicles within the area.

In the month of May, we identified two littering offences from this area, both drivers have now been issued with a fixed penalty notice.

Overall, this camera has been a positive deterrent, due to on-going reports from local residents of anti-social behaviour and loud vehicles, this has now believed to have stopped this behaviour from happening within this area. Compared to the level of reports before the camera was deployed to this location, there does appear to be a drop-in activity.

This camera is in place due to reports of anti-social behaviour and drug related issues.

During the month of August, we identified three separate instances involving one vehicle and one individual making exchanges within the street. We have provided this to the Police for further intelligence. We also identified a number of instances whereby motorbikes/mopeds passed the camera, both riders not wearing helmets. We provided this footage to the Police, along with clear facial images of the riders.

We identified two individuals dumping large parts of a sofa, we have supplied this to Milton Keynes Environmental Crime Unit, and this is currently being investigated.

While surveying this area we identified two fly tips including letters and packages with names and addresses on. We therefore supplied this to Milton Keynes Environmental Crime Unit and created an evidence pack. We are now aware that two separate fixed penalty notices have been issued to the two individuals who dumped this rubbish at Ormonde.

This camera has been deployed due to ongoing environmental issues within the area.

During the month of July, we identified two separate vehicle's littering when parked up within this location. Both of the offences have now been fully investigated and both drivers have been issued separately with a fixed penalty notice for littering. We also have identified that the littering offences currently do not appear to be school related traffic.

In June, we identified one vehicle littering when parked up within this location. We also identified one vehicle littering out of the driver's window and into the road when driving past the camera, both individuals have now received a fixed penalty notice.

During the month of May, we received a Police request for this location. We reviewed a large amount of footage and communicated our findings with the Police.

During the month of April, we had no requests or concerns from this area. On the day this camera was deployed many members of the Public witnessed this camera being deployed and therefore we believe this deterred a very large number of usual incidents.

The camera was deployed here for multiple criteria such as anti-social behaviour and littering issues. In the month of March, when reviewing the camera, we identified damage to the grass area, and we then identified two vehicles crossing over the grassed area and leaving this damage behind. We secured this footage and supplied this to Milton Keynes Environmental Crime Unit for investigation. We have identified one instance of waste being dumped by an individual, this individual has since been issued with a fixed penalty notice.

During February, we identified the driver of a vehicle littering here and this individual received a fixed penalty notice. We identified a nearby resident leaving large bags of dog foul waste in this location. We have provided this footage to the Council. We provided footage of this area to the police following a nearby fence being set on fire / criminal damage.

We also identified a further separate incident of two motorcycles riding on the park area here, this footage was passed to the Police.

In January, we identified a vehicle driving onto the park area here. We have provided this footage to the police. The police recognised the vehicle and spoke to the driver.

A camera has been located here due to reports of anti-social behaviour and littering issues.

During February, we provided a document to the police of our ongoing findings from the area, which evidences the numerous complaints of suspicious behaviour in the area.

In consultation with Stantonbury Council and the Police we removed this camera due to the level of evidence found previously.

In January, we began collecting evidence due to multiple comings and goings from one of the properties in view and creating a document for this containing all evidence. In December, we identified a possible "exchange" made here and contacted the Police providing this evidence.

This camera was deployed due to multiple issues such as criminal damage and ASB. Following on from seven reports of vehicle damage and damage to residential properties we located a camera in this area. The camera was first directed to the [REDACTED] area where there were multiple reports of ASB. We reviewed this location consistently and there were no further incidents observed or reported. Overall, this camera was a positive deterrent, due to on-going reports from local residents of anti-social behaviour and criminal damage, this camera stopped this behaviour from happening within this area.

Following this we have reangled the camera to view the [REDACTED] where again there have been reports of ASB and vehicle damage. We identified an instance of littering here. We have completed the evidence pack and have passed this to the council for investigation. This individual has now received a fixed penalty notice.

Since the camera installation in this central position, the criminal damage and ASB reports ceased.

This camera was deployed to this area due to multiple reports of vehicle break-ins. This is following three reports in the area of vehicle break ins. After this camera was deployed, and during the time of the camera being in place, no further reports of vehicle break-ins were made. This camera deterred all activity from commencing within this area.

This camera was deployed to this area urgently due to reports of anti-social behaviour. Whilst on site we observed some materials that had been set alight and ashes which indicated recent activity. Since installation of the camera, no further reports of anti-social behaviour were recorded within this area, we reviewed this camera daily and did not identify further suggestions of anti-social behaviour, this camera was a positive deterrent.
